ACODE RANKED AMONG THE BEST GLOBAL THINK TANKS

he Global Go To Think Tank Index Report 2017 ranked once again has ACODE as the best Think Tank in Uganda, and among the Top Think Tanks in the world. The rankings produced annually by the University of Pennsylvania through its Think Tanks and Civil Societies Program (TTCSP) play a major role in policy development and implementation and ACODE is happy to be part of this fraternity.

ACODE was ranked number 15 out of 90 Think Tanks globally assessed on the parameter of having the "Best Advocacy" in the category of Top Think Tanks by Special Achievement (Policy Engagement). Table 1 summarizes ACODE's ranking in this category since 2012.

ACODE is in the League of Think Tanks with excellent Advocacy Campaigns in Europe and North America. All Think Tanks that ranked 1–14 were from Europe and North America. ACODE is not only the number one Think Tank in 2017 in the category of advocacy in Africa but in the rest of the world (Latin America, Asia and the Pacifics)





CONTRIBUTING TO POLICY DEVELOPMENT REFORMS AND IMPLEMENTATION THROUGH RESEARCH AND ANALYSIS

publications outed in 2017

n ACODE, we focus our work on creating synergy between policy interventions and our policy research. Through policy research and analysis, we help governments and international development agencies to expand the range of policy choices necessary to confront challenging and sometimes controversial public policy matters. In 2017, research was undertaken in different thematic areas: Budget Transparency and Accountability, Enhancing Natural Resource Governance and Assessing Local Governance and Service Delivery.

Enhancing Service Delivery Through Local Government Councils' Performance Assessments

The 7th Local Government Assessment was conducted in 33 districts in Uganda with the outputs including 35 district specific reports and one national synthesis report. The synthesis report compares performance of the district elected leaders across the districts and focuses on their role in the decentralisation process. After the launch of the report witnessed by over 300 stakeholders, findings from the study were disseminated to various stakeholders, including citizens at local government levels. At the international level, ACODE participated in the process of reviewing a manuscript submitted to the *Commonwealth Journal on Local Governance*.

Budget Transparency and Accountability

In a bid to contribute to the shaping of the economic policy in Uganda and East Africa, ACODE, Centre for Budget and Economic Governance, published and launched an online newsletter entitled, *ACODE's CBEG Economic Briefer*. The publication, which aims at providing policy makers with alternative ideas on contemporary economics, was disseminated to various stakeholders. As a tool to further engage policy makers on issues of education policies, we completed and published a study on public expenditure in education titled, *Assessment*

of Public Expenditure Governance of the Universal Primary Education Programme in Uganda.

Another studv titled "Public Expenditure Governance and Performance of Agricultural Extension Systems in Uganda" on the public expenditure in agriculture, covering 10 districts in Uganda was completed. The findings of the study, provided a deeper understanding of agricultural extension services and suggested ways in which its governance and outcomes could be improved.

Natural Resources Governance

Uganda's natural resources (especially extractives) provide unique opportunity to foster human and economic development. However, poor governance of these resources can erode the country's ability to utilise its natural wealth to improve socio-economic wellbeing of its citizens. ACODE focused on improving policy space for citizen participation in decision making, improve policy frameworks by providing alternative policy ideas and contributing to strengthening mechanisms accountability in policy implementation and revenue generation and utilisation.

Strengthening governance of the petroleum sub sector


ACODE undertook study on stakeholder participation in the oil and gas sector, oil revenue tracking, developed a tool for gender integration in the petroleum sector and participated in the monitoring of oil and gas development activities in the Albertine Graben. This informed the National Local Content Policy, draft Land Acquisition, Rehabilitation and Resettlement Policy (LARRP). It also enriched civil society submissions to the Land Inquiry Commission and the Parliamentary inquiry on the utilisation of oil revenues.

ACODE participated in assessing the implementation of the Strategic Environmental Assessment (SEA) for the Albertine Graben and integration of green growth principles in the oil and gas sector, which has been dubbed, 'greening the oil and gas sector'.

Enhancing Access to Justice in Uganda's Forestry sub-Sector

ACODE undertook a Comparative Study on Access to Justice in the forestry sector Uganda and Tanzania. The study provides insights on the state of access to justice in the forestry sector in the two countries and provides

lessons for Uganda. A policy briefing paper on enhancing the role of courts in promoting forest justice was produced, published and disseminated to and the key actors in the justice, law and order sector. This briefing paper makes a number of recommendations for enhancing the role of courts in promoting forest justice. Positive feedback was received especially from judicial officers who acknowledged the relevance of the recommendations.

Improving policy and investment practice in China and Africa

As part of the effort to improve policy and investment practice in China and Africa, with the aim of fostering good stewardship of forest resources and benefit poor men and women, ACODE undertook research entitled, *Socio-Economic Effects of Chinese Agricultural Investments on the Environment and Local Livelihoods in Uganda*. Five hundred copies of the publication were disseminated to both the primary and secondary stakeholders.





POLICY OUTREACH AND INCREASED CIVIC ENGAGEMENT

ne of the pillars at ACODE, is the ability to use research for interventions that improve civic awareness of their rights and obligations. We also cohere to empowering citizens to demand for service delivery and accountability from their government, through imparting knowledge, skills and providing vast platforms that nature communication among all stakeholders. Through policy outreach and advocacy, ACODE contributes to the formulation of public policies that support sustainable development, thereby expanding livelihood and income opportunities for poor people. This section puts the spotlight on some of the activities that were done to achieve our goal.

Activating the Demand side of local governance through Civic Engagement Action Plans (CEAPs)

The Civic Engagement Action Plans (CEAPs) resulting from the civic engagement meetings are new innovative intervention that ACODE has developed to activate the demand side of democracy as envisaged by the scorecard's theory of change. The CEAPs, focus on citizens at local government and sub county levels, have been credited for triggering the virtuous circle of mutual empowerment of both the communities and their elected local leadership. Over 220 action plans were drafted from the meetings that were organised in all the sub counties in the 35 districts. The impact from the CEAPs is documented in some of the case stories. as profiled.

CEAP CASE STORY:

Mbale - Nkonkonjeru Road Rehabilitated After Petition.

In Mbale district, citizens from Wanale and Budwale Sub-counties

unanimously decried the impassable Mbale- Nkonkonjeru road amidst other existing service delivery challenges.

The citizens' voices on this road were echoed in 3 out of the 4 civic engagement meetings conducted in the 2 sub-counties. This road had last been rehabilitated in the early 80's. In Wanale sub-county,



this concern was voiced during a civic engagement meeting conducted in July, attended by 31 citizens. In line with the civic engagement action plan they developed. This group of women, men, youth and elderly, wrote a letter to the office of the Speaker of Council seeking intervention.

Since this is a road under the mandate of the Uganda National Roads Authority (UNRA), the Speaker forwarded the demand to the office of the Director – UNRA, Mbale regional office requesting for urgent reabilitation of the road. The matter was also brought to the attention of the area Member of Parliament who, through a phone call to the research team, confirmed having engaged the president over the matter. Ultimately, by the time our team undertook monitoring in November, works on this road had started. This is proof that the petition had impacted on the relevant authorities.



As referenced above we humbly submit in our petition to your nonsurface in regard to the damming state of the road and this has attributed to a number of accidents especially during wet seasons to mention but a few a woman under labour pain died on the way to mbale Regional Refferal Hospital from Wanale Health Centre III and many others.

This was a tarmac road but to our dismay it has been washed away by heavy rains. Several communications have been made from various offices to renovate / maintain it but all in vain.

Therefore the purpose of this letter is to request your office to intervene into this matter to alert the situation / come on ground to reaffirm this.

State of the Nation (STON) Platform

The State of the Nation Platform is a forum on which stakeholders from different sections of society meet to discuss contemporary issues with the aim of influencing public policies. With over 70 members of the public who are strategically drawn from intergovernmental organisations, parliament, media, society, embassies, security organisations, government, civil society and academia, the platform continues to draw attention to critical issues that arise locally and globally. ACODE held 5 sessions of the STON, discussing contemporary issues focused on Governance of Universal Primary Education and its implication to national development, Green Growth Economy in Uganda: Strategies for Sustainable Development and Inclusive Growth and Food Security, Climate Change, and Disaster Preparedness: Interventions to avert the looming Food crisis in Uganda and Eastern Africa among others.

Advocacy on Biotechnology Bill

ACODE continued to provide leadership in the civil society sector on the analysis of the National Biotechnology and Biosafety Bill. ACODE presented proposals to the Parliamentary Committee on Science and Technology. As a result of the advocacy on the Biotechnology Bill, the President declined to assent to the bill siting the numerous contentious clauses that were detrimental to Ugandans and he asked Parliament to address the issues.

Fronting ideal Governance of Uganda's Agriculture sector

In partnership with the International Institute of Tropical Agriculture (IITA) and Ministry of Agriculture, Animal Industry and Fisheries (MAAIF), under the Policy Action for Sustainable Intensification of Ugandan Cropping Systems (PASIC) Project, ACODE organized high level breakfast meeting and policy dialogues at both national and regional (zonal) level which influenced policy development, and budget implementation processes.

The high level stakeholder engagements culminated into increased budget to cater for the much-needed non-wage (operational) funds to implement the National Agricultural Extension Policy (2016),



changes in the development process of the draft National Seed Policy (2016) and the Draft Plant and Genetic Resources for Food and Agriculture Policy (2008)

At the regional level, ACODE also facilitated a series of zonal dialogues to;

- ✓ create awareness of national agricultural policies
- ✓ discuss the policy implementation progress at the local government level
- ✓ facilitate the development process and enforcement of by-laws and ordinances to support the effective policy implementation as well as ensure sustainable intensification of cropping systems at the local government level.

Sustaining Debate on Natural Resources Governance

Seeking to provide opportunities for stakeholders to learn about green growth economy; share information

on Uganda's green growth strategies, progress toward greening its economy . Also, discussions on the discuss strategies for Uganda's potential financing modalities for green growth, a high Level Policy Dialogue on "Green Growth Economy in Uganda: Strategies for Sustainable Development and Inclusive Growth" were held.

Increased accountability and strengthened advocacy on forestry-related matters

ACODE conducted and participated in a number of activities that increased accountability in the governance of Uganda's forestry resources and strengthened advocacy on forestry-related issues. In partnership with CARE International in Uganda, the Forest Sector Support Department (FSSD), the National Forestry Authority (NFA) and Mid-Western Region Anti-Corruption Coalition (MIRAC), and sucessfully organized the Bunyoro Forestry Governance and Advocacy Forum at Kolping Hotel, Hoima.

Also, ACODE in partnership with CARE International in Uganda and Masindi NGO Forum, organised the Inter-District Multi-Stakeholder Forum on Bunvoro Forestry and Environment Governance which took place in Masindi., These for a provided opportunities to different stakeholders to demand for accountability from the duty bearers in as far as management of the forest resources is concerned. The platforms were also an opportunity for stakeholders to advance critical forest governance issues and facilitate increased access to forest information. Stakeholders from the districts in Bunyoro region took the decision to establish the Bunyoro Inter-District Multi-Stakeholder Forum on Forestry and Environment Governance as a permanent multi-stakeholder platform to address forestry and environmental governance issues in the region.


Reinvigoration of debate and efforts to save and protect river systems in Uganda

Destruction of Uganda's river systems is one of the factors causing and accelerating climate change. A case in point is the destruction and degradation of River Rwizi catchment. that is a major source of water to over 8 districts in western Uganda. Over the years, the volume of the water in River Rwizi has significantly reduced, mainly due to human encroachment on the forests, wetlands and other sensitive ecosystems along the river course. This is compounded by waste discharge into the river.

Concerned by this state of affairs, with financial support from CARE International in Uganda and the Green Economy Coalition, ACODE, in partnership with Mbarara District Local Government and NBS TV, organized a conference in Mbarara under the theme *Restoration and sustainable Management of River Rwizi for Development and Livelihood Security*. The conference which converged stakeholders from Government, civil society and the private sector focused on triggering debate, setting the agenda and redirecting efforts to the completion and implementation of the plan that had been started on to restore the catchment area.

Improved regional engagements on oil and gas sector


ACODE participated in a regional dialogue on the proposed East African Crude Oil Pipeline (EACOP) in which a Joint Communiqué, with a set of recommendations, was developed to lobby the governments and the oil companies to ensure environmental, livelihood and other aspects of compliance during the design and construction of the EACOP.

High Level Policy Dialogue on the Budget

ACODE annually holds a high level policy dialogue on the budget with the aim of analysing the newly released budget, issues that are vital in it and providing a platform on which different stakeholders share their views so as to influence public policies in various sectors. In this year, ACODE, in partnership with the Ministry of Finance, Planning and Economic Development (MFPED), held the 7th high level policy dialogue on the budget. The dialogue that was attended by 100 participants and watched live on NBS TV by approximately 8 million people was themed, *Unlocking Uganda's Economic Potential: Investing in Strategic Sectors of the Economy.*

The Africa Think Tank Summit

ACODE took part in the Africa think tank summit that took place in Abidjan Ivory Coast. The summit, which focused on the role of Think Tanks in the industrialization of Africa, presented an opportunity for ACODE to contribute to this important Africa wide agenda-setting. The discussions at the Summit also provided a good context for reflection on our work.

Dialogue on Uganda's Economic Outlook

ACODE, in partnership with the Hewlett Foundation and Ministry of Finance, Planning and Economic Development, organized a breakfast dialogue on Uganda's Economic Outlook and Service Delivery in Kampala. The dialogue, which was attended by various stakeholders, was addressed by the President of the Board of Hewlett Foundation, Secretary to the Treasury (MoFPED) and the Chair Board of Trustees of ACODE among others.

...a high level policy dialogue on the budget with the aim of analysing the newly released budget, the vital issues of concern and providing a platform for different stakeholders share their views so as to influence public policies in the various sectors.

CAPACITY BUILDING FOR STAKEHOLDERS

Capacity Building Engagements

ACODE, through capacity building, empowers communities to demand for justice and promotes public participation and Acitizens' demand for accountability in decision-making processes that affect their livelihoods and the environment.

Capacity Building for selected local government leaders and CSOs

Five district workshops were organised in Sheema, Kaliro, Lwengo, Kabale and Kisoro. Since the local government political and technical leaders were participating in the local government assessments for the first time, they needed orientation. During the district assessments that took place, our team provided support to the various district teams with the aim of ensuring that all district researchers followed the scorecard methodology and ethical research standards to reduce the possibility of bias.

Training of researchers and budget champions

ACODE undertook a training of researchers and budget champion coordinators from districts with the aim of preparing the researchers for field activities, including conducting Civic engagement Meetings (CEMs) and monitoring execution of CEAPs using a revised methodology described in the CEAPs Manual. A total of 105 participants took part in this training.

Engaging District leaders through Peer Learning

In a bid to provide a platform for sharing best practices among local governments, a district leaders' peer learning forum was held, focusing on effective leadership skills for local governments. This training convened 100 participants including district chairpersons, speakers, Residential District Commissioners and clerks to councils from 20 districts. Outreach Engagements

Training on Business Skills

Under the *Supporting Business Opportunities for Rural Women* project, ACODE trained 151 women in business in various business skills such as book keeping, preparing a business and marketing plan as well as value addition processes. The participants were drawn from those who participated in baseline study in the three study sites: Soroti, Mukono and Mbarara. A selected group of 20 women who participated in the training were mentored in the application of the skills they acquired in the training for three months, through personal visits and peer learning events organised at district level.


BUILDING NETWORKS FOR ENHANCED POLICY ENGAGEMENT

Green Economy Coalition Membership

CODE became a member of the Green Economy Coalition (GEC) and participated in the GEC leaders' annual global summit held in Trinidad and Tobago. The global summit focussed on how to support green enterprises so they can drive the transition to inclusive green economies.

ACODE also participated in the Switch Africa Green Networking Forum, a networking forum that aimed at fostering open information and knowledge sharing, among stakeholders on Uganda's transition towards an inclusive green economy.

Supporting Business Opportunities for Rural Women in East and Southern Africa

In collaboration with the Institute of Environmental Studies (IES), Zimbabwe and the Collaborative Centre for Gender and Development (CCGD), ACODE embarked on a collaborative study that investigated and generated evidence on structural barriers, which constrain women from taking advantage of business opportunities. This background paper is under review for publication.

Partnership with the Consortium for Economic and Social Research (CRES)

ACODE, in partnership with the Consortium for Economic and Social Research (CRES) in Senegal, embarked on a collaborative research initiative on *Gender Responsive Budgeting in Africa: An Action Learning Project in Senegal and Uganda*. The initiative focuses on building capacity of Citizens, CSOs and policy makers to take part in gender budgeting as well as monitoring implementation of gender budgets with particular emphasis to the subnational level.

Civil Society Coalition on Oil and Gas in Uganda

ACODE, continued to provide the secretariat and offer support to the Civil Society Coalition on oil and gas in Uganda (CSCO). This network aims to achieve many milestones including the , reviewing the Draft National Oil Spills Contingency Plans, reviewing and contributing to the land Acquisition, Resettlements and Rehabilitation Policy (LARRP) and monitoring of Oil and gas Infrastructure.

Partnership with Kalamazoo College – Michigan, USA

ACODE participated in a fellowship at Kalamazoo College in Michigan, USA, with the aim of working with the university students to analyze qualitative data collected during the FY 2016/17 assessment. The fellowship also provided a forum to teach the students about ACODE and the scorecard project while the partnership also includes an international internship arrangement where one university student was hosted at ACODE for one month. The student worked with the scorecard team to provide research support during the compilation and publication of the 7th scorecard report.

Partnership With Selected Civil Society Organizations

We continued working with three civil society organizations to promote transparency and accountability in nine districts across Uganda namely: Kabarole Research and Resource Center (KRC), Teso Anti-Corruption Coalition (TAC) and Community Development and Child Welfare Initiatives (CODI). The roles of these organizations largely focused on coordinating Budget Champion activities in the nine districts.

We continued partnering with the Ministry of Finance and Economic Planning , Uganda Local government Association, Next Media (NBSTV) and Nation Television (NTV) under respective M.o.Us. with the objective of influencing public policies.

CEAPs were held in 2017 and these empowered citizens to articulate their service delivery needs and empowered them to prioritize the needs with consideration of the ever growing pressure on the limited resources at the disposal of the local governments.



RISING TO THE CHALLENGE OF COMMUNICATING RESEARCH

ith the ever growing and evolving trends communication channels and methods. ACODE continued to engage multimedia systems to craft and disseminate messages based on our research. Focus on feedback mechanisms from our publics was tailor made to suit various target audiences to further achieve the mission of making public policies work for the people. This section highlights the Information Communication and Technology (ICT) activities that were found useful.

An environmental media campaign focusing on oil and gas was embarked on with the aim of raising awareness among the public on the relation of activities oil and gas and the environment. On NBS Television, 48 broadcasts were aired on the *Environment Focus*, setting the agenda on issues of the environment.

Public Policy Library and ICT Innovation

Over the last decade, the landscape of public policy research communication has been undergoing a significant shift in a many ways of ways. The visible emergence of new technologies has been accompanied by other shifts in the understanding of what constitutes expert knowledge, a growing emphasis on process over product in research and new understandings of what drives social change and policy influence.

At ACODE, we endeavour to dovetail theory with practice and support demand for research by developing uptake strategies that engage with those for whom we think that research makes the most difference throughout the lifecycle. Our library strengthened the partnership with the Africa Portal – a project of the Africa initiative – coordinated by the South African Institute for International Affairs (SAIIA) to widen information access on the African Continent so that researchers,

practitioners and policymakers can utilise our work. We also revolutionised citizen access to our structured datasets on the national budget over a web-based platform to promote the demand side of accountability in public expenditure governance.


While ACODE continued to share with partners, academicians and researchers extensive policy material in our library, we made strides in pushing our research products beyond borders through multi-media data channels:

- Citizen Budget Database: The new improved database was moved to its new home http://budgetacode.org to provide easy access to simplified national budget information on all sectors of public expenditure.
- Africa Portal Library: An online resource library that seeks to broaden the availability, accessibility and use of policy research the African Continent. We strengthened our partnership with other content partners to replenish the library that has opened our virtual doors to the rest of Africa and beyond.
- SMS Platform: We continued to improve citizen engagement through our improved information and feedback channels. The SMS platforms including the Citizen Budget Information Network (CBIN) and Local Government SMS Platform and the new Citizen Monitor Mobile App all work together to strengthen our civic engagement in the delivery of public goods and services.



- The Website: http://acode-u.org is the main gateway to the rest of the world that has helped us rise to the new challenges of communicating research. This website is the home of all research products published over the last 19 years It is a useful resource for researchers, academicians, policy makers and other users looking for policy research materials in Africa.

KEY ACHIEVEMENTS IN 2017

Generation of new knowledge and contribution to evidence based policy making:

ACODE undertook 70 research studies that contributed to new knowledge and informed formulation and implementation of various policies, legislation and government programmes.

ACODE 7th Annual Local Government Councils' Scorecard Report and 29 district briefs informed the debate on decentralisation process and service delivery in Uganda informed the design of the District performance assessment tool that is being used by government of Uganda to assess performance of District Local Governments. This was accomplished under the the local governance initiative.

Under the natural resources governance portfolio, the studies ACODE carried out informed the review of the National Environment Management Act. They also informed the development of draft guidelines for benefit sharing under Uganda's central forest reserves, development of environmental and social safeguards for large scale land based investments in Uganda, Oil spill Contingency plan for the petroleum subsector, , the Resettlement Action Plans and land access for the oil development projects, in particular TILENGA, KFDA and King Fisher in Buliisa and Hoima Districts respectively. The Environment and Social impact Assessment for the East Africa Crude Oil Pipeline and the implementation of Green Growth Strategy were also informed.

ACODE Public Expenditure Governance Studies (PEGS) in Education and agriculture generated issues that will inform the reforms in the agriculture extension and education. The Budget and Service Delivery Monitoring Exercises (BSDME) contributed to adjusted reforms in government monitoring resource allocation and service delivery.

Reinvigoration of the debate and efforts to conserve forest ecosystem, rivers and river systems in Uganda

ACODE, with support from CARE International, Green Economy coalition and collaboration the local governments, Ministry of Water and Environment, and NBS television organized a national dialogue and three sub-national level dialogues in Ankole and Bunyoro on restoration and sustainable management of forests and forest ecosystems, and rivers and rivers systems in Uganda. The discussions at the dialogues resulted into declarations and a set of commitments from several stakeholders including central government, district local governments and CSOs to take action and restore the forest and river ecosystems in the country. The discussions also led to the creation of sub-national level forums for example the Bunyoro Inter-District Multi-Stakeholder Forum on Forestry and Environment Governance which has become a regular multistakeholder platform to address forestry and environmental governance issues in the region.

Informed national and sub-national discussions on oil governance in Uganda

ACODE actively participated in two East African regional dialogues, organised national multistakeholder dialogues, sub-national dialogues and learning events and community engagement meetings on various themes ranging including: the impacts of East African Crude pipeline on environment and people and other related infrastructure, land acquisition for investment, resettlement and compensation, Land rights, Transparency and accountability in the oil and gas sector, local content and stakeholder participation in the oil and gas sector. ACODE supported the production and dissemination of 48 television feature stories on extractives governance and environmental conservation. The stories were disseminated to over 8 million Ugandans and informed the public debate on the subject.

Contribution to capacity building to improve local governance and service delivery in the country

ACODE enhanced the capacity of citizens and political leaders to understand and play their respective roles and responsibilities in the democratic process. Through the Civic Engagement Action Plans (CEAPs), capacity building sessions and peer learning exchange visits by different council members, and radio talk shows, we built the capacity of 783 policy makers and political leaders in 35 District Local Governments and reached over 13.8 Million Ugandans with information about the roles and responsibilities of their leaders and how to hold them accountable. The capacity building initiatives for political leaders have enhanced the understanding of their roles while CEMs and CEAPs have enhanced citizen competence and confidence to demand better service delivery from local and national government.

Coordinating civil society engagement in the oil and gas sector

During the year, ACODE continued to host, coordinate and provide learning opportunities for civil society organisations working on oil governance issues. The civil Society Coalition on oil and gas (CSCO) continued to provide a forum through which oil governance issues are generated and shared with duty bearers. The forum also provides an opportunity for feedback. Through this platform, Over 60 NGOs working on oil and gas were able to generate a memorandum of issues that informed the review of the National Environment Act, the draft National Land Acquisition, Resettlement and Rehabilitation Policy and the Environmental and Social Impact Assessment for the East African Crude Oil pipeline, among others.

Enhancing Citizen Participation in budget processes and contributing to budget transparency and accountability

WeACODE was able to share budget information and provide feed- back to government under the Budget Transparency Initiative in partnership with the Ministry of Finance Planning and Economic Development (MFPED) and the Budget Strengthening Initiative (BSI) of the Overseas Development Initiative (ODI). ACODE Centre for Budget and Economic Governance (CBEG) redesigned the online budget database and launched the Citizen Monitor Mobile Application in order to provide budget information to citizens and obtain from citizens' feedback on the budget and service delivery. Through national and sub-national dialogues on the budget and television programmes, ACODE provided a forum through which the citizens provided input into the budget process.

Strengthened institutional capacity in the research and advocacy

ACODE was able to produce quality research products that were used to inform various government policies and programs. ACODE was once again rated by the Think Tanks and Civil Societies Program (TTCSP) at the University of Pennsylvania, among the top global think Tanks and the best Advocacy think tank in Uganda.
